THE HISTORIC SPRING LAKE CIVIC CENTER RENOVATION PROJECT

The renovation project continues to move full speed ahead. As we prepare for completion of the renovation work and for the reopening and dedication of the center, we are thoughtful of all who have helped us to reach this point. We, along with the community, have been good stewards of the gift left by the Sandhills Civic Association. The history of the Spring Lake Civic Center and the community that built and sustained it for

so many years has inspired others to believe in our vision for the renovated civic center. Renovate, Restore and Reopen was our call to action. And the response was encouraging. Soon, the newly renovated building will reopen and enjoy new life as a community resource and tourism center.

Renovate, Restore and Reopen

The renovation plan for the Spring Lake Civic Center is tied to its historic relevance to the community and plans to apply for addition of the building to the National Register of Historic Places. The civic center will be restored to its original appearance, based on its historic use as an open assembly hall by the community.



Sandhills African-American Heritage Center

The Sandhills African-American Heritage Center will serve as a cultural heritage tourism site, community resource center and a place for social, economic and environmental education. The building will house SFHA, our programs of H.O.P.E and our work to preserve the history and heritage of African-Americans in the NC Sandhills. The grounds of the Heritage Center - which include the Sandhills Farmers & Heritage Market, the Brush Arbor, the Native Plant Trail and a replica of the Old Plank Road - will continue to serve as a tourist stop on the African-American Heritage Trail.

Representative Lucas was instrumental in securing the Directed **Grant from the NC General Assembly to support** the renovation project. Mayor Kia Anthony and The Conservation Fund's Resourceful Communities Representatives Visit Spring Lake Cemetery

Let's begin by understanding the purpose of a cemetery. In simple terms, a cemetery is a place set aside for the remains of individuals who have died to be buried in a specific, identifiable space. For anyone who has had a loved one die, visits to what is considered a sacred space, allow opportunities for mourning and to show respect for the deceased.

The topic of cemeteries has taken on significant meaning for Sandhills Family Heritage Association (SFHA). In the last two years SFHA was gifted a local cemetery where enslaved people were buried who once worked on a local turpentine plantation. Stories of its existence were passed down but the exact location was unknown by later generations. Overgrowth by vegetation concealed this burial site keeping its exact location a mystery. It was finally located and grave sites were identified using aerial technology. Gifted to SFHA by the family who last owned the land, Deerfield Cemetery will be restored and its history preserved to honor and show respect for those who are resting there.

SFHA has listed the Deerfield Cemetery on the NC Site File - a permanent registry of historic sites, archaeological sites, and historic cemeteries.

Restoration will begin following many hours of research to determine who is buried and what their lives might have been like. Several steps and individuals will be a part of this major project which could take years to complete. NOW is the time for estate planning and advanced directives so that you can have peace of mind and your vision is known and your wishes are followed.

Sandhills Family Heritage Association recently hosted a wills clinic in partnership with Land Loss Prevention Project (LLPP) of Durham. This community outreach service allowed participants to have three important legal documents created and notarized onsite Last Will and Testament, Healthcare Power of Attorney and General Power of Attorney.




